been subsidised by Government and it will remain at BDS 23.5375 cents/kWh until further notice. In June, the subsidised fuel clause for residential customers continued at 23.5275 cents per kWh while the non-subsidised fuel clause for all other customers it was BDS 39.4286 cents/kWh. If these were not subsidised the bills would be about 38% higher for these customers.
